He has over 20 years of formal involvement in issues impacting American Indian tribes, including government relations, community development, environmental and cultural planning, environmental justice, cultural and historic preservation consultation, and economic development. Our team works with project stakeholders to facilitate the consultation process so that culturally appropriate, respectful decisions can occur in a way that is satisfactory to Indian tribal nations and sensitive to project requirements and agency responsibilities. We support federal agency goals to build cooperative long-term relationships with tribes that attach cultural and religious significance to archaeological sites and ancestral remains. Engagement may culminate in the incorporation of tribal cultural specialists on project surveys, creation of Tribal Consultation Teams, incorporation of tribal knowledge into archaeological documents, and development of cultural competency training.
